Subject: Aadhaar Enrolment for school going children from Class-I to XII.

Sir

In connection with the above subject, I have the honour to state that this Directorate has taken up exercise for ensuring Aadhaar enrolment of all school going children reading in Class-I to XII in the State. The entire exercise is being taken up in consultation with Deputy Commissioners, Officials of MANITRON, IN-MEDIA, DIT, and Education (S) Department. A circular has also been issued to all the concerned for Aadhaar Enrolment (a copy of the same is enclosed for reference).

It may be brought to your kind notice that Notification No. 5/12(9)/2010-H (Census-12) Pt dated the 27<sup>th</sup> February, 2017, it is stated that generation of Aadhaar, shall be based on NPR receipts only.


It may be placed for information that the school going children were either quite small to be admitted to Schools or could have been left out when NPR database were captured and it is therefore proposed that NPR receipts may be relaxed for school going children for their Aadhaar enrolment. Else the time bound exercise will be delayed and another parallel exercise prior to Aadhaar enrolment may have to be initiated.

It is proposed that Aadhaar enrolment may be taken up for school students based on

- (a) Certificate of Identity/Residence (Proof of Identity & Proof of Address as required for Aadhaar Enrolment) issued by Head of Institute/School or Concerned AIs/DI/ZEOs in their letter head. (A template is enclosed for ready reference) or
- (b) For Class XI and XII students, Class X pass certificate for DOB may be added or
- (c) As per the documents listed in the list of documents for Aadhaar enrolment.
